Entry fees are \$110.00 for 4 runs. Entries are limited to the first 20 dogs.

We will offer the new Dasher Scent 3 on June 2 and 9 for \$22.00 extra each run.

We will offer the new Dasher Scent 3 on May 5 and 12 FEO for \$10.00 extra each run.

Qualifying ribbons will be awarded to each team who qualifies each week. Qualifying ribbons will be awarded for Dasher Scent 3 Teams who qualify June 2, 9. No ribbons for Dasher Scent 3 FEO runs.
